## SCHOOL RULES

The registration fee plus the 1st monthly payment will be charged in cash at the time of affiliation. The registration fee is non-refundable.

**Monthly payments will be made during the first 10 days of every month.** The student who does not pay can not continue receiving classes.

All **returned receipts** or bank checks will have a surcharge of **€ 5**.

**Students** must **notify** the teacher, as well as the School at the front desk, at the beginning of the course, of their **intention to examine** themselves outside the School (in case they wish to do such examination).

Students who wish to cancel, must **make sure to notify us of their intention by email 10 days before the beginning of the month.** Otherwise students will have to pay the amount of the following month.

The **school calendar** published by the **Generalitat** of Catalonia is to be observed and followed.

Any possibility of **recovering classes** lost for reasons beyond the School is **denied**. Only those classes which the teacher has not been able to impart (only for professional reasons or illness) will be **recovered**.

**Any change** in the time and duration of the classes **will be communicated** to the school staff before it occurs. To set it up with the teacher is not enough.

In the event that the student can **not attend** a class, he or she will **notify this as early as possible**.

**Lack of attendance** does **not imply the non-payment** of receipts.

The student must be **respectful** with the **facilities** of the School.

The student undertakes to leave the **space** where he or she has rehearsed, **clean and tidy** after use.

**Smoking is not allowed** in any of the internal and external facilities of the School, nor at the front door in the street. It is **not allowed to eat** in the classrooms.

• The School is not responsible for the damage, loss or theft of any object of the student or his or her companions.

**Note for the parents of the younger students:** It is totally **forbidden to climb the metal gates** that surround the courtyard of the School. We ask special attention to the parents, since there are children who walk there and it is dangerous.

Parents or guardians of **under-age students** are advised **not to leave them alone** in the School outside of class hours, as the School will not be held responsible. In any case, the parents who leave them alone will have to notify the School staff, although the School will **not be held responsible**.

The School reserves the **right of admission** and the right to cancel a group if it does not reach the minimum number of students.

In accordance with the **General Regulation on Data Protection (RGPD)**, your personal data and those of your child will be part of a file owned by Alícia Alcalay Rosès, with address at Calle Balmes 53, pral. of Barcelona, which undertakes to comply with the **obligation of confidentiality**.

The personal data are only and strictly used to carry out the correct services of the School and will be exclusively used for the purpose exposed: the management of the activity, issuance of receipts and contact. For its proper use, the data can be transferred to third-party entities that provide services to the School and that comply with the RGPD.
